Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6890'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Nio perms @ 6940')
4. TIH with CIBP. Set BP at 4400'. Top with 2 sxs 15.8#/gal CI G cement. (Sussex Coverage)
5. TIH with CIBP. Set BP at 2500'. Top with 2 sxs 15.8#/gal CI G cement.
6. Wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or fluid migration, contact engineering before continuing operations.
7. Pick up with tubing to 1650'. RU cementing company. Mix and pump 146 sxs 15.8#/gal CI G cement down tubing. Cement circulate to surface.
8. Well casing cut and capped per COGCC guidelines at a depth as not to interfere with soil cultivation.
