Inspection #696202924 documented that BMPs to protect and stabilize and the cut and fill slopes of the Location, and access road are missing or insufficient.

Documents attached shows Operator has placed a wattle along the toe of the slopes of the access road; no other control measures documented within the resolution; BMP alone is an inadequate control measure to address stabilization concerns on the slopes.

Additionally, Operator has not provided documentation showing adequate BMPs to protect and stabilize the cut and fill slopes of the Location have been implemented per good engineering practices, per the corrective action.
