Operator Comment: Stormwater diversion ditch along the perimeter of the location, including armoring and outlets, has been maintained and in proper functioning condition. Silt fence on the west end of the location has been maintained and in proper functioning condition. Additional revegetation activities have been conducted per SG's plan for this location, which has been previously communicated with COGCC. Hydromulch, soil amendment and seed has been spread on disturbed areas to stabilize and protect slopes. Additional seeding has occurred. Fencing has been placed around revegetated areas to assist with vegetation growth. Seeded areas will be watered as needed depending on weather. See attached photos.
