On 8/3/2021, a release occurred at the Razor 26 CPB. Less than 1 bbl of crude oil released from a compressor blowdown malfunction. The majority of the fluid remained on location with a mist of oil leaving location and impacting an area to the southeast off pad of approximately 125' by 20'.
