#### COMMENTS:

Approval of alternative MIT is requested per Rule 326.b(3). Bradenhead tests have been submitted annually on the well showing no braidenhead pressure and positive casing pressure. The most recent braidenhead test conducted on 6/11/2021 verified no braidenhead pressure or flow and a casing pressure of 600 psi proving that the wellbore has integrity and no casing leak exists. Well pressures including braidenhead will be monitored monthly to ensure integrity.

The gas pipeline for this well was shut-in in October 2018 due to a Western Gas pipeline leak. Goodwin Energy intends to return the well to production when Western reactivates the gas line.
