**General Comment:****COGCC Inspection Report Summary**

On Friday 8/6/2021 at approximately 1100, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus Figure Four M11, at Location # 335785 in Rio Blanco county Colorado.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area and BLM stipulations area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls. During this inspection the following compliance issues were observed:

1. No battery signage.
  2. Location shows signs of lack of stabilization/compaction
  3. Culvert at location entrance/access road is failing
- Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
