The following was observed on location: Wellhead and wellhead sign present, small debris and trash laying around location, it appeared that some on location flowlines were still in the ground, other production equipment was removed, tank berm was still present, gravel present inside tank battery, stained soil inside tank battery. The operator should assure that forms related to plugging have been submitted (form 6) and continue to communicate closure of pit on the form 27 and with COGCC staff, Kris Neidel. Corrective Actions: remove gravel from tank battery prior to final reclamation, remove stained soil and sample below staining per REM # 17616, Remove all trash and debris from location, Comply with COA's of REM project 17616.
