TA due to high opex. Plan to use as monitor well for pressure observation. Wells are used to monitor bottom hole pressure in the Weber formation to help manage our CO2 flood. The well is isolated with closed valves on the wellhead, disconnected flowline, isolation packer at 6199', and a tubing plug at 6201'. This well has potential H2S concentrations known to exceed 100 ppm. Please refer to Chevron's Rangely H2S Operations, Monitoring, and Public Protection Plan for H2S monitoring plan.
