Comment: The stream crossing which was washed out in the spring flood event has been rebuilt. There are multiple culverts of various sizes installed which does not appear to be an engineered installation. Further along the access road are multiple culverts filled in with sediment that need maintenance. Areas of erosion along the access road need to be repaired. The stream crossing needs to be installed per good engineer practice demonstrated by a stamped engineer design plan submitted by form 4.
