## Comment

Previous inspection observed that Operator conducted additional disturbance/excavation activities within the eastern interim areas of the Location; historic aerial imagery shows these areas were associated with a drilling pit. Inspection required Operator to submit a Form 4 with documentation/information as to why the interim areas were redisturbed by 4/20/2021, and to reclaim disturbance by 5/13/2021.

It was observed that the reclamation work has been performed; however, documentation/information attached to a Form 4 was not submitted; corrective action has not been addressed in its entirety and remains applicable.
