General Comment:

This is an environmental inspection to document status of Spill 478196 discovered during COGCC inspection on 9/28/2020. Spill report 402499942 reported COGCC Inspector Tom Beardslee reported water leak on a segment of gathering line at Vallejo 44-5V well location. A failure in a 4" T caused the 9.22 barrel spill.

COGCC Area EPS on location requested sampling of produced water from wellhead, impacted area and downstream from impacted area. No flowing water was found during inspection. Pools of produced water and pools of stormwater/natural groundwater from seeps were observed during inspection. Spill flowed approximately 300 feet east/northeast down drainage that contained a marsh (see attached photos of drainage bottom).

Operator shall provide root cause of spill and prevention procedures on Form 19 Supplemental within 10 days of spill as required per Rule 906.b Operator shall obtain water samples from spill location, wellhead and background location and submit on a Form 19 Supplemental.
