#### COMMENTS:

As a result of a failed MIT test performed on the Nordman Estates #10-7 associated with mitigation efforts for the recently drilled GMT horizontal offset well, a casing leak was identified. No indications of a casing integrity issue were present prior to the failed MIT test. A casing hole was isolated to between 3164'-3195'. A small 50 sack squeeze job was performed down tubing and will be drilled out. A new MIT test will be passed and the well will be placed back on production. Verbal approval for the work was obtained from the COGCC staff.
