Please see the attached Spill Investigation Site Diagram for proposed spill investigation points. These were selected to characterize the approximate spill area from the reported surface spill of drill cuttings and drilling mud. Given the immediate response and recovery of the cuttings as outlined in the Initial Form 19, Caerus will investigate each identified surface location between zero (0) and six (6) inches below ground surface (bgs). Each spill investigation area will be field-screened with visual and olfactory observations and a photo-ionization detector (PID) to identify potentially impacted soil. Investigated soil will also be photographed to document presence/absence of soil staining. If no impacts are identified during the investigation, Caerus will document these findings without sample collection on a Supplemental Form 27. Continued in Operator Comments.
