Comment:

This is a follow up final reclamation inspection from 2017 and 2019. Operator performed additional final reclamation activities in response to the 2017 corrective action. The 2019 inspection left the location in process. This inspection confirms the well location and well location access road are reflective of reference area vegetative levels. Sand dropseed is the dominant perennial grass species throughout the location and reference areas.

The associated offsite tank battery is still in use for another nearby well operated by a different Operator.

The other associated well (001-06542) was passed in 2019, as it was part of an active location (Location ID 434399); therefore, it was a well release on an active location.
