	<p>1) Provide 2 business day notice of plugging MIRU via electronic Form 42.</p> <p>2) After placing the shallowest hydrocarbon isolating plug (3500'), operator must wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or of fluid migration, contact COGCC engineering before continuing operations.</p> <p>3) Prior to placing the 800' plug: verify that all fluid migration (liquid and gas) has been eliminated. If evidence of fluid migration or pressure remains, contact COGCC Engineer for an update to plugging orders.</p> <p>4) After isolation has been verified, pump plug and displace. If cement is not circulated to surface, shut-in, WOC 4 hours then tag plug – must be at 195' or shallower and provide 10 sx plug at the surface.</p> <p>5) Leave at least 100' of cement in the wellbore for each plug.</p> <p>6) With the Form 6 SRA operator must provide written documentation, which positively affirms each COA has been addressed.</p>
	Operator will implement measures to capture, combust, or control emissions to protect health and safety, and to ensure that vapors and odors from well plugging operations do not constitute a nuisance or hazard to public health, welfare and the environment.
