Operator has performed final reclamation activities, with the evidence of drill rows and straw crimped mulch throughout portion of the access road, well location and tank battery. Final reclamation will remain in-process since the well location and access road do not yet meet Rule 1004 standards. Undesirable weeds, Kochia and Russian thistle, were observed along some portions of the access road, which will need to be managed in the future.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004.
