Comment: Excavation has been initiated. Soil contamination and free product were observed. No crews were on location at the time of inspection. Water present during time of inspection is presumed to be rainwater. However, If infiltration of water persists, site characterization will be required. Free product visible on water.

Corrective Action: Operator will provide notice to COGCC EPS Nikki Graber (nikki.graber@state.co.us) at least 48 hours prior to backfill, monitoring well installation, or any sampling events performed on location. Note that samples collected must be analyzed for Table 915-1 parameters.
