Comment: Remediation Project #10763 from a spill initially documented in 2016 is still active. Continue to comply with 900 series rules and regulations. Active remediation should not preclude the commencement of final reclamation activities. Final reclamation has not yet been performed in all areas outside the identified contamination zone at the tank battery.

Corrective Action: Work with the Environmental Specialist to sample all soils collected from the base and sidewalls of the final excavation for agronomic properties per the 915-1 soil suitability for reclamation section. Per the 27S submitted 8-12-2021 all information and sampling requested above must be gathered and analyzed by the end of the third quarter 2021. Final excavation sampling should include the deepest plant root depth to assess potential agronomic issues.

Comment:

The well location and associated access road appear to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.
 The tank battery location does not comply with Rule 1004. Reclamation rules require reclamation activities on well site and associated facilities to be conducted within three months of plugging on cropland. Another well servicing the lower 1/2 of the tank battery (API#05-123-18322) was plugged and abandoned on 12/4/2020.

Corrective Action: **Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be completed in such a manner as to not interfere with agricultural activities or crop production. Provide documentation within the FIR Resolution form of when the corrective action work will be completed and provided date and documentation of coordination with the surface owner. The inspection corrective actions reflect the location was observed out of compliance.**

Comment: **At the time of this inspection, there was observed storm water erosion along the western portion of the tank battery, which is impacting reclamation areas. It appears that irrigation water from the adjacent crop fields are draining towards the western portion of the tank battery. This is causing channelized flows which is causing gully erosion. Per the rules run-on protection are required.**

Corrective Action: **Comply with Rule 1002.f. Install or repair required BMPs per Rule 1002.f.**
