The Siebring 5-63-32 DUCs are scheduled to have pre-frac heavy equipment ops starting 9/13/2021, pending approval of the sundry (Form 4 doc# 402686100). Shut-in bradenhead pressure for this well is 15 psi (Form 17 doc# 402794525). BCEI is pausing mitigation efforts on this well in preparation for frac. Pressure charts of blowdowns conducted from March to present are attached. Post frac, BCEI will conduct the required bradenhead tests within 60 days of first sales and will evaluate the need for additional mitigation.
