The initial production casing test was performed on the Federal RG 341-18-297 well on 8/30/2021. The production casing was pressured up to 9002 psi and leaked off 1170 psi over 30 minutes, a 13% pressure loss.

TEP Rocky Mountain LLC (TEP) respectfully requests permission to rig up a workover rig with a work string, packer, and fresh water to locate the depth of the casing leak. Once the casing leak depth is determined, TEP will submit a subsequent sundry that includes a remediation plan to fix the leak.
