Steel panel fencing in place surrounding excavation. No Operator staff present at time of inspection

Ongoing Remediation project 19028 at now closed spill 479834.

Sorbent booms observed in main excavation in effort to minimize horizontal transport of crude oil in precipitation event are not in place near hydrocarbon liquids at time of inspection. This inspection entered to document conditions observed at time of inspection. Operator has indicated they removed observed hydrocarbon liquids prior to this inspection being submitted.

No barrier to prevent infiltration of crude oil and associated impacts to deeper soils and to shallow groundwater at site during precipitation or irrigation events.

Weeds noted in previous two inspection (07/21/2021 and 08/17/2021) have been removed from excavation area.
