COMMENTS:

Crandell 0-8-26 was previously tied into the production flowline to keep the bradenhead pressure below 50 psi for mitigation. A form 17 annual test was performed on 08/16/2021. A surface and production casing sample were taken. For the 30 minute bradenhead test, the surface casing flowed 226 scf. The samples previously taken showed the gas signature from production and surface casing samples did not match. Crestone will continue with the current mitigation plan and will conduct the next annual test again in 2022.

Description

	1. Operator shall implement measures to control venting, to protect health and safety, and to ensure that vapors and odors from well operations do not constitute a nuisance or hazard to public welfare. 2. Bradenhead gas is not to be vented to the atmosphere; any gas from the Bradenhead will be routed to the specified abatement system. Shut in bradenhead pressure shall not exceed 50 psig. Operator shall implement measures to get an estimate of the gas flow rate and/or volume from the bradenhead. 3. Within thirty days of 09/07/2022, submit a Form 4 Sundry that summarizes current well condition. The sundry should include details of the future plans, sample analysis interpretation, bradenhead test description, and the flow rate information and pressure data. 4. Shut well in for at least seven days to monitor build up pressures then conduct a new bradenhead test and submit the Form 17 within ten days of the test. 5. If a sample has not been collected from surface casing within the last twelve months collect bradenhead gas samples for laboratory analysis. Sampling shall comply with Operator Guidance - Bradenhead Testing and Reporting Instructions, Appendix A: Liquid and Gas Sampling. Copies of all final laboratory analytical results shall be provided to the COGCC within three months of collecting the samples.
