


Comments / Descriptions / Explanations
<p>Two BMP crews worked on the Cascade Creek 697-09-61 pad in response to COGCC Document #696203107. In areas which are either too steep to safely install erosion control blankets and/or areas which are too rocky to effectively install erosion control blankets were broadcast seeded with QuickGuard, tall wheatgrass, and Upper Cascade Seed Mix and treated with a blend of liquified soil amenities and plant nutrients. A total of 20 pounds of seed and 2,025 gallons of liquid treatment were applied. The crews also swept the pad for litter, construction debris, and noxious weeds.</p>
