A 5.66 bbl produced water spill to land from a buried 3 inch Corvel coated line just off of pad at MC Hagood A8. Spill entered a dry unnamed feature. 5 bbls of fluids were recovered, line was immediately isolated upon discovery and all proper notifications were made. Clean up continues and area is being water washed with fresh water from the main water plant.
