While there, I observed an incorrect lease name on the battery sign, illegible contents and capacity placard on the crude oil tank and illegible capacity placard on the produced water tank sign. During this inspection the following possible compliance issues were observed: Rule 605.e. with a corrective action date of 12/10//2021, Rule 605.h. with a corrective action date of 12/10//2021.                      A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
