All tanks need NFPA placard replaced. Install sign to comply with Rule 605 h. (Corrective Action Date: October 2, 2021) See attached photos #12-16. 2. Weeds surrounding tank battery and some of location. Remove to comply with Rule 606. (Corrective Action Date: October 2, 2021) See attached photos #2-8. 3. Unused equipment on location (east of tank battery/at pumpjack). Remove to comply with Rule 606. (Corrective Action Date: October 2, 2021) See attached photos #7, 8. 4. It appears to be stained soil at pumpjack and at equipment behind the tank battery. Conduct maintenance on equipment, cleanup stained material and review self inspection processes per Rule 1002.(2).d.
