Tasman Geosciences, under the direction of PDC Energy, Inc., collects water samples from the influent and effluent process streams of the methane mitigation systems installed on DWR Well Permit Numbers 137465 and 268360 on a quarterly basis and submits them to Summit Scientific Laboratories for analysis of dissolved gases by EPA Method RSK 175. In addition, the samples collected from the influent process streams are submitted to Dolan Integration Group (DIG) for hydrocarbon gas composition and stable isotopes analysis.

**OPERATOR COMMENT**

Tasman Geosciences, under the direction of PDC Energy, Inc., collects water samples from the influent and effluent process streams of the methane mitigation systems installed on DWR Well Permit Numbers 137465 and 268360 on a quarterly basis. The data associated with the third quarter 2020 (first sampling event) through the second quarter 2021 (most recent sampling event) is presented in this Form 27. Please refer to the Supplemental Form 27 Investigation/Workplans submitted by PDC Energy, Inc. referenced in the Related Forms tab of this Form 27.

Great Western is currently in the process of addressing the five COAs associated with the Supplemental Form 27 Investigation/Workplan Document #402444533.

COA #1 (Addressed): A structure contour map of the bottom of the Fox Hills Formation under and adjacent to the 0.75 mile radius study area around the Morales water well is attached.

COA #2 (Addressed/Ongoing): Quarterly sampling and analysis of DWR Well Permit Numbers 137465 and 268360, managed by PDC Energy, Inc., is ongoing.

COA #3 (Ongoing): Great Western is currently conducting further evaluation of possible sources of thermogenic gases present in the two water wells. An update will be provided in the next quarterly Supplemental Form 27 submittal.

COA #4 (Addressed): Please refer to the attached Shoe Pressure Failure Calculation Worksheet and Soil Vapor Monitoring Report.

COA #5 (Ongoing): Great Western is currently conducting research to gain a better understanding of local and formation variability in gas composition and isotopic ratios. An update will be provided in the next quarterly Supplemental Form 27 submittal.
