Mr. Tappy was encouraged to file a formal complaint via the COGCC website and he responded that he has not received performance of the required work on the part of the Operator (Magpie Operating Inc.) from the previous formal complaints he has filed (see well file for FIR details). At the time of this FIR, the location described as the Warnecke 1, Logan County, Colorado remains in a condition that continues to restrict returning the land to farmland as required.
