2020 annual test had 63 PSI gas flow that blew down to 0 psi in thirty minutes. Abatement system follow-up test had 63 PSI that blew down to 0 PSI within thirty minutes. A sample was able to be obtained and analyzed. Bradenhead gas determined to be thermogenic gas with a similar composition as the production gas sample. PDC plans to P&A this well per COGCC requirements.(This well is not equipped with a bradenhead pressure transducer.)
