**General Comment:**

COGCC Inspection Report Summary

On Tuesday 9/13/2021 at approximately 1000, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP RU 34-6, at Location # 335044 in Garfield county Colorado.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad, there is no evidence of a tracking pad at time of inspection.

During this inspection the following compliance issues were observed:

1. Staining near well heads.
2. Lack of bull plugs/caps at load out lines.
3. Three quad unit horizontal separators includes four glycol storage tanks, approximately 174" x 34" x 41" = 25 BBLS x 6, storage vessels contain no labeling to specify capacity or chemical hazard information.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
