INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On January 28, 2021, field screening and confirmation soil sampling was conducted in accordance with the COGCC Rule 911 during the decommissioning and closure of the Owl Creek 7, 7-5 tank battery. Based on the initial results, a historic release was discovered below the produced water vessel on January 29, 2021. Following the discovery, mitigation activities were initiated to delineate and remove remaining hydrocarbon impacts. During the removal of the produced water vessel, groundwater was observed in the excavation at approximately 7 feet below ground surface (bgs). Approximately 2,154 cubic yards of impacted material were excavated and transported to the North Weld Waste Management Facility for disposal under PDC waste manifests.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

On January 28, 2021, the soil sample (PWV01-W) that was collected from the source area (adjacent to the produced water vessel) at approximately 2.5 feet below ground surface (bgs) was submitted to Summit Scientific Laboratories (Summit) for analysis of the full COGCC Table 915-1 analyte list. Preliminary analytical results indicate that site specific containments of concern (COCs) include benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH C6-C36), 1,2,4-trimethylbenzene (TMB), fluorene, and 1-methylnaphthalene (M). Between February 16 and February 22, 2021, 50 soil samples (SS01 - SS50) were collected from the sidewalls and base of the excavation at depths ranging between 3 feet and 7.5 feet bgs and were submitted for laboratory analysis of the above referenced COCs. Analytical results are summarized in Tables 1 through 4. The laboratory reports are included in Attachment A.

On February 22, 2021, one groundwater sample (GW01) was collected from the excavation following the completion of source mass removal activities and submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-TMB, and 1,3,5-TMB. Analytical results indicated that constituent concentrations were below the applicable COGCC Table 915-1 groundwater standards.

The source soil sample (PWV01-W) exhibited arsenic and selenium concentrations and pH levels in exceedance of the applicable COGCC Table 915-1 standards. Therefore, a background sample (BKG-TB) collected within the shallow soil horizon and submitted for laboratory analysis of the COGCC Table 915-1 metals and soil suitability including pH, electrical conductivity, sodium adsorption ratio (SAR), and boron.

Twelve (12) monitoring wells will be installed via direct-push drilling methods to confirm the absence of dissolved-phase hydrocarbon impacts within and surrounding the former excavation extent. Lithologic descriptions and volatile organic compound (VOC) concentrations using a photoionization detector (PID) will be recorded for each borehole. If elevated VOC concentrations are encountered during the investigation, a sample will be collected from the interval exhibiting the highest VOC concentration from the borehole and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH C6-C36) by EPA Methods 8260B and 8015. Proposed monitoring well locations are illustrated on Figure 2.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Between January 28 and February 22, 2021, approximately 2154 cubic yards of impacted material were excavated and transported to the North Weld Waste Management Facility in Ault, Colorado for disposal under PDC waste manifests. During excavation activities, groundwater was encountered within the excavation at approximately 7 feet below ground surface (bgs). Groundwater vacuum recovery activities were conducted concurrent with excavation activities and approximately 220 barrels of groundwater were removed and transported to the NGL Energy disposal facility for disposal.

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Based on the analytical results collected during the initial groundwater assessment conducted in the second quarter 2021, monitored natural attenuation (MNA) will be the selected remediation strategy for this location for the fourth quarter 2021.

Groundwater monitoring will continue on a quarterly basis at the 2 site monitoring wells (BH09 and BH12) and ten temporary monitoring wells (BH01R, BH02, BH03R-BH06R, BH07 - BH08, BH10R, and BH11). Based on the analytical results collected during the second quarter 2021, groundwater samples will be submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260B, chlorides and sulfates by EPA Method 300.0, and total dissolved solids (TDS) by method SM 2540C in accordance with Table 915-1. Quarterly groundwater monitoring will continue until closure criteria is achieved.
