Corrective Action

1) Conduct an audit of all locations for weed compliance by no later than October 7, 2021. Submit a summary report to COGCC Staff, Chris Binschus, via a Form 4 Sundry by October 21, 2021.

2) After the Operator conducts the audit, Operator shall develop a plan and schedule to perform weed management. Operator shall include the plan and schedule within the Form 4 Sundry.

Note- COGCC Staff may request at any time, documentation of compliance for any of the locations. Operator will be required to provide documentation of compliance within 48 hours of the request.
