Due to other tank batteries with similar weed compliance issues, COGCC Staff has concerns that other locations also have weed compliance issues. Operator shall conduct the following corrective actions.

Corrective Action

1) Conduct an audit of all locations for weed compliance by no later than October 7, 2021. Submit a summary report to COGCC Staff, Chris Binschus, via a Form 4 Sundry by October 21, 2021.

2) After the Operator conducts the audit, Operator shall develop a plan and schedule to perform weed management. Operator shall include the plan and schedule within the Form 4 Sundry.

Note- COGCC Staff may request at any time, documentation of compliance for any of the locations. Operator will be required to provide documentation of compliance within 48 hours of the request.
