Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

Friday (05-01-2015) at approximately 6:20 AM a leak occurred on the injection line to AC McLaughlin 63, due to internal corrosion on a 3" coated spool. Approximately 97.4 BBLs of produced water and 0 BBLs oil were released. The lateral lines were shut in immediately upon detection. Vacuum truck recovered an estimated 95 BBLs. Total spill was contained on location.
