A compromised separator released approximately 2.5 bbls of oil to the ground outside of containment. The separator is scheduled to be replaced and the impacted soil will be removed. Confirmation soil samples will be collected and submitted for laboratory analysis. Soil samples will be analyzed in compliance with COGCC Table 915-1 for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) and organic compounds in soil. Analytical results will be included in a supplemental report.

The impacted soil is being removed and hauled to a COGCC approved disposal facility. The work is being prolonged due to the need to remove production equipment and excavate around several buried flowlines. Impacts are extending deeper than expected, all flow and dumphines in the area are scheduled to be hydrotested to verify integrity. Confirmation soil samples will be collected and submitted for laboratory analysis as proposed in the initial report. Analytical results will be provided in a subsequent Form 19.
