KPK is currently investigating if high SAR is naturally occurring or more excavation will need to be done.

This remediation project is being opened to close Spill ID 480127. KPK had anticipated closing the spill before the 90 day time limit from the initial Form 19, however, unexpected high levels of SAR were observed in lab results and will need to be investigated by KPK. Arsenic levels are within 1.25x of background. No other exceedances of table 915 are observed at this time. Attached are initial sample results from the excavation walls. KPK will be doing additional sampling before requesting closure.
