INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Historical impacts were discovered during reclamation activities at the HSR-Van Schaack 4-33 production facility, and excavation activities were initiated. On June 12, 2020, groundwater was encountered in the excavation area at approximately 9.5 feet below ground surface (bgs); groundwater was subsequently observed at 5 feet bgs while excavation activities were ongoing. The COGCC issued Spill/Release Point ID 476912 for this release.

Soil samples were collected as described in the Initial Form 27 (COGCC Document No. 402433337). Based on the data presented, impacted soils in the excavation area were remediated to be in full compliance with the COGCC Table 910-1 standards. Based on the date of discovery and initiation of excavation activities (June 12, 2020), the COGCC Table 910-1 soil standards have been applied to the soil analytical results at this location.

Proposed Groundwater Sampling

On October 28, 2020, five (5) temporary groundwater monitoring wells (BH01 - BH05) were installed to further assess the extent of groundwater impacts. Quarterly groundwater monitoring was initiated on November 12, 2020, and is ongoing. Groundwater analytical data is presented in Table 1, and the groundwater sample locations are illustrated on Figure 1. The laboratory analytical report for the Third Quarter 2021 groundwater monitoring event is provided as Attachment A.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Between June 12 and 15, 2020, approximately 330 cubic yards of impacted material were excavated and transported to the Buffalo Ridge Landfill in Keenesburg, Colorado for disposal. Between June 12 and 16, 2020, approximately 795 barrels of groundwater were removed from the excavation area via vacuum truck and transported to the Kerr-McGee Aggregate Recycle Facility in Weld County, Colorado for recycling.

REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Laboratory analytical data indicate that impacted soils in the excavation area have been remediated to be in full compliance with the COGCC Table 910-1 standards. Prior to backfilling, approximately 165 pounds of OxPure® activated carbon were added to the groundwater within the excavation area to mitigate remaining hydrocarbon impacts in groundwater. Quarterly groundwater monitoring is ongoing and will be continued until concentrations remain in compliance with the COGCC Table 915-1 standards. Additional remedial activities may be evaluated, as necessary, to address remaining groundwater impacts. Estimated time to attain NFA is TBD based on the groundwater concentrations, the extent of impacted groundwater, and the efficacy of the selected remedial technologies.

On October 28, 2020, 5 temporary groundwater monitoring wells (BH01 - BH05) were installed to further assess the extent of groundwater impacts. The 5 temporary monitoring wells will continue to be sampled on a quarterly basis and submitted for laboratory analysis of Table 915-1 constituents. Upgradient and historically compliant groundwater monitoring well BH04 was selected from the Third Quarter 2021 monitoring event as a background location for comparison to inorganic groundwater standards in Table 915-1. Based on a comparison to background concentrations, the total dissolved solids (TDS) and sulfate concentrations in monitoring well BH02 were above the COGCC standards in Table 915-1 during the Third Quarter 2021 monitoring event. Kerr-McGee will continue to evaluate POC for Table 915-1 standards on a quarterly basis, based on the site-specific local background concentrations. The temporary monitoring well locations are illustrated on Figure 1, and a potentiometric surface contour map for the Third Quarter 2021 is presented as Figure 2. Well completion logs for the temporary monitoring wells are provided as Attachment B.
