I tried to voice concerns before the wells went up, they said they would be great neighbors, then when I contacted them they said they were in compliance and would do what they could. They said I could go to court to oppose the wells but I didn't have childcare to do so and was afraid as I was kicked off social media when I voiced concern. I dropped my complaint in hopes they would be good neighbors but that isn't the case.

I also recently found out they had an unreported spill and given their closeness to my home and the flood plain I'm very bothered by that for safety reasons.

I beg of the state to do whatever is necessary to protect residents over the businesses that are encroaching on homes that were there first.
