Comment: It appears repairs were performed but have since failed. There is erosion occurring along the access road transporting sediment off site. Sediment has filled into the rock rip/rap dams. Areas of erosion along the access road need to be repaired and properly stabilized to prevent erosion. BMP's need to be selected based on site conditions which may include but not limited to gravel, compaction, sediment traps, check dams, ect.
