- 1) Horizontal separator includes glycol storage tank. Glycol storage tank is approximately 2'x3'x10' with an approximate capacity of 11 barrels. Glycol storage tank missing required information with a corrective action date of 12/24/21.
- 2) Unused chemical tank with a corrective action date of 10/24/21.
