Laboratory results of spill investigation soil samples indicate concentrations of arsenic concentrations exceeding COGCC Table 910-1 within the historical spill area. However, background data suggests that these exceedances are within naturally occurring levels at the Location. Background samples collected from the nearby C16OU (COGCC Location ID 334416) indicate arsenic concentrations ranging up to 18.4 mg/kg. Based on these results, no additional investigation or remediation activities appear to be warranted.
