Contact COGCC engineering.</p> <p>Comply with COGCC annual bradenhead testing rules. 10/1/21</p> <p>Before leaving location spoke with Martin Resources LLC supervisor. Was asked about what proper procedures were for blowing down a well. I informed him that there are rules in place to protect the public, that requires them to use equipment to burn the gas other than letting raw gas escape into the atmosphere to relieve pressure within proximity of neighbors. He told me he would be contacting P3 representatives to discuss plans of action to mitigate issues on location.
