Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

on 9/24/2021, a pumper from Caerus was working at the D24W pad and notified Summit personel of a possible gas release at approximately 18:35. Summit Operations investigated, but could find no finite evidence of a leak. Out of caution, the line was blown down, shut in, and locked out. Summit Operations further investigated on 9/27/2021 by repressurizing the line, and using a FLIR camera to identify whether a leak was present, and if it was on the Caerus wellpad, or on Summit's gathering line. A leak was found on Summit's line, which was promptly blown down, shut in, and locked out again. Summit will excavate the line to determine the extent of the leak and any impacts to the soil.
