INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with COGCC Rule 911, this form serves as notification for the abandonment of the Schlagel 5-26 wellhead and removal of the associated flowline. The ground and sub-surfaces will be visually inspected for hydrocarbon impacts during abandonment activities. Field observations and photo documentation will be recorded in a field inspection form for submittal to the COGCC.

Proposed Soil Sampling

Soil samples will be collected from the surface in cardinal directions of the wellhead, as defined in the Rule 911.a.(4) guidance document (1/4/21), for field screening purposes. Discrete soil samples will be collected for laboratory analysis either in any area of observed hydrocarbon impacts, or adjacent to the cut and capped wellhead from native material and below the flowline riser. GPS data will be collected for all soil sample locations. Soil samples will be submitted for laboratory for analysis of Organic Compounds in Soil, TPH (C6-C36), and Soil Suitability for Reclamation by COGCC approved methods. Refer to the Wellhead and Flowline Location Map. A sample location figure will be provided in the Supplemental Form 27.

Proposed Groundwater Sampling

If groundwater is encountered during decommissioning and/or abandonment activities at designated laboratory sample locations, a grab groundwater sample will be collected as soon as practical. If groundwater is encountered at designated field screening sample locations, a groundwater sample will not be collected unless field screening indicates that potentially hydrocarbon-impacted soils are present. If contaminated soil is in contact with groundwater, or if free product/hydrocarbon sheen is observed, the release will be reported in accordance with Rule 912.b. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260.

Additional Investigative Actions

☐ Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Assessments will be conducted during the removal of this off-location flowline (estimated to be 1860 feet in length) approximately every 250 feet and at the flowline endcaps. Additional assessments will be conducted where the direction changes from S to W and W to NW, and in the areas where the flowline is in close proximity to sensitive areas, such as surface water and FWS wetlands. The flowline and adjacent sub-surface will be inspected for any visual and olfactory indicators of potential failure and hydrocarbon impacts. Soils will be field screened below the flowline and if suspected impacts are observed, a soil sample will be collected for an initial assessment and submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-TMB, 1,3,5-TMB, and TPH (C6-C36). If analytical results indicate the presence of organic compound concentrations, the sample will be analyzed for the full Table 915-1 suite. GPS data and photo documentation will be recorded for each inspection/sample location.
