A site investigation will be conducted pursuant to COGCC rule 911 at the North Platte 11-24 Pad (310062) oil and gas location as pertaining to the cut/cap of the North Platte 11-24 wellhead and removal of the NP 11-24 WH Line. This off-location flowline, approx 1206-ft, will be removed. See site map exhibit for details.

Two grab soil samples (at wellhead and at flowline terminus) were collected for analysis of TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected for lab analysis were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
