There is one stock watering well within 1/4 of a mile (DWR Receipt #9065625/ DWR Permit # 81435) at ~570' NW of the flowline end point point and ~815' to the N of the North Platte 24A wellhead (flowline start point). This is not considered domestic.

The closest water well with a static water level reported is DWR Receipt 31096 at ~2000' NE from the flowline end point with a static water level of 112'. Upon the evaluation of the nearby water wells we believe groundwater to be greater than 20'.

The Pronghorn Winter Concentration density habitat falls within 1/4 of a mile.

All samples collected for lab analysis were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
