Remove to comply with Rule 606. (Corrective Action Date: October 29, 2021) See attached photos #3-6. 2. 3 tanks do not display contents sign. (Recommend to replace produced water signage, very faded) Install sign to comply with Rule 605.h. (Corrective Actions Date: October 29, 2021) See attached photos #7-9.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
