 On 9-27-2021, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Maintenance. The complainant Vera Pilliteri 12761 Cacaugh Rd Hudson CO stated the issues were occurring at a wellsite next to complainants home.
 On 9-27-2021, I attempted to make contact with the complainant spoke with complainants husband who indicated over the last several years well appears to be not operating, lack of maintenance and a spill that occurred approx... Two and a half years ago.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did observe several maintenance issues on wellsite and production facility witch are listed in the inspector comments portion of this inspection. Since the spill or release occurred approx. two and a half years prior to inspection, I did not see any evidence of issue stated in complaint.
 Weather conditions: Dry and clear.
 Violations of COGCC rules were observed at the time of the inspection.
 All information reviewed and site inspection information has been submitted to the COGCC for further review.
