Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the WERNING 07-02B wellhead cut and cap and flowline removal. Approximately 2,270' of flowline will be removed. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead will be cut and capped per COGCC rules. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.
