Erosional tunneling first observed in 2018 is continuing within the eastern project area. Additionally stormwater BMPs are full of sediment and unmaintained. Operator has failed to monitor and maintain stormwater BMPs to prevent erosion.

-Stabilize erosion within the project area. Stormwater controls need to be selected, sized, installed, and maintained according to good engineering practices. No corrective action date applied due to the duration of non-compliance. It is the expectation that corrective action be immediately addressed.
